- **TREASURER** maintains the financial records, receives membership dues, pays bills and expenses, prepares a monthly report to the LCWRT on financial status, files an annual form to the IRS confirming a non-profit corporation, assists at monthly program meetings.
- **SECRETARY** maintain minutes of Executive Committee meetings, handles LCWRT correspondence, assists at monthly program meetings.
- **MEMBER-AT-LARGE** assists the President, assists at monthly program meetings.
- **PROGRAMS COMMITTEE** helps identify and locate speakers for program meetings. Coordinates with Sun City Life Styles to obtain meeting rooms and any special needs for program speakers. Assists at monthly program meetings.
- **MEMBERSHIP COMMITTEE** maintains LCWRT membership roster on an easy-touse spreadsheet. Prepares a monthly report to the Executive Committee on membership status. Prepares membership badges. Prepares an annual report to Sun City Life Styles to maintain our status as a "Registered Community Group" within Sun City. Assists at monthly program meetings.
- **COMMUNICATIONS COMMITTEE** -- Prepares the monthly *Minie Ball Gazette* newsletter. Provides monthly update for Sun City **SunSations** magazine. Maintains the LCWRT website. Assists at monthly program meetings.
- **ASSIST AT MONTHLY PROGRAM MEETINGS** meet and greet members as they arrive, assist in seating, assist setting up for program speaker.
